Elena Berdysheva holds a PhD in sociology and is currently Senior Research Fellow at the Laboratory for Studies in Economic Sociology, National Research University Higher School of Economics (Moscow, Russia). Berdysheva specializes in the development of valuation studies and the sociology of medicine. She teaches courses on the sociology of taboo markets, health and illness in market societies, and qualitative sociological research for the study of modern markets and organizational fields.

Elena Bogdanova has been an associate professor at the European University at St. Petersburg and the Russian Presidential Academy of National Economy and Public Administration since 2016, and a research fellow at the Centre for Independent Social Research (CISR, Saint Petersburg, Russia) since 2001. She received a candidate of sciences degree in sociology in 2006 and a PhD degree from the University of Eastern Finland in 2021. Bogdanova has published nearly 50 articles. Her research interests include the sociology of aging, research of justice and regulative systems, Soviet society and postsocialist transformations, and qualitative research methods. Bogdanova is one of the editors of *Communism and Consumerism: The Soviet Alternative to the Affluent Society* (Brill, 2015) and the author of *Complaints to the Authorities in Russia: A Trap between Tradition and Legal Modernization* (Routledge, 2021).

Olga Brednikova is a research fellow at the Centre for Independent Social Research (Saint Petersburg, Russia). Brednikova received a PhD in sociology from the National Research University Higher School of Economics (Moscow, Russia) in 2020; her dissertation topic was “Integration of Migrants from Central Asia in Russian Society.” Brednikova’s current research interests include migration, neighborhood and urban studies, national borders and borderlands, and the sociology of everyday life.

Liubov Chernysheva is an urban sociologist, a research fellow at the Centre for Independent Social Research (Saint Petersburg, Russia), and a PhD candidate at the Amsterdam Institute for Social Science Research (University of Amsterdam, Netherlands). Her PhD dissertation focuses on life-in-common in a postsocialist city. As part of several research projects, she studies urban commons, grassroots initiatives, and practices of sharing, governing, and digitally mediating everyday realities in various kinds of neighborly relations and housing.

Irina Finkelstein is a lecturer in the Department of Sociology, Samara National Research University (Russia). She was part of a collective project examining the problem of medical choice made by doctors and patients (2017–2019, RFBR, headed by Vitaly Lekhtser). Finkelstein's publications based on the results of this study have appeared in the journals *Vestnik SPbSU* (in 2018) and *Sotsiologicheskii zhurnal* (in 2019, coauthored with Anna Gotlib and Vitaly Lekhtsier).

Elvira Gizatullina is a human geographer and urban researcher with master's degrees in human geography, and urban design and urban studies. She has participated in research and applied projects in urban sociology and urban development. Gizatullina is a leading researcher for the international research project "Estates after Transition" (EAT) and a member of the Open Urban Lab expert platform.

Olga Gromasheva received a master's degree in sociology from the European University at St. Petersburg (Russia) in 2008. She is currently working on her doctoral dissertation that investigates direct purchases of food from local farmers by Saint Petersburg consumers. She is an invited researcher on the Russian-Finnish project, funded by the Kone Foundation, that explores neighborliness with nonhumans. Gromasheva has participated in several international projects and authored multiple research articles in Russian, English, and Portuguese on informal economy, sociology of risk, gender studies, and practices of food consumption, published in journals like *Anthropology of Food* and *Demokratizatsiya: The Journal of Post-Soviet Democratization*.

Pavel Kupriyanov is a historian, anthropologist, and senior researcher at the Institute of Ethnology and Anthropology of the Russian Academy of Sciences (Moscow). He is a member of the editorial board of the journal *Etnograficheskoe obozrenie*. His research interests include problems of ethno-cultural and local identity, neotraditionalism, urban anthropology, and memory studies. Kupriyanov does archival and field research in different regions of Russia. He is the author of several dozen publications and a coauthor of the anthropological film *An Important Place, or Live in the Center* (2010).

Danila Nedikov is a graduate of the National Research University Higher School of Economics (Moscow, Russia), with a bachelor's degree in economic sociology; his senior thesis was titled "Mechanisms for Constructing the Quality of 'Soft Drugs' on the Russian Darknet." Nedikov is now working on the master's thesis that investigates the problem of price calculations in the Russian darknet.

Ekaterina Rudneva is a researcher at the Laboratory of Anthropological Linguistics, Institute of Linguistics of the Russian Academy of Sciences (Saint Petersburg, Russia). She graduated from the Department of Theoretical Linguistics of the Philological Faculty, Saint Petersburg State University, with a bachelor's degree in 2008 and received a master's degree in sociolinguistics from the same institution in 2010. Rud-

neva was enrolled in the PhD program in the Department of Anthropology at the European University at St. Petersburg (2014–2017) and in 2019 defended her PhD thesis “Strategies of Linguistic Politeness in Spontaneous Talk-in-Interaction.” Her main areas of research interests include analysis of face-to-face interaction and linguistic pragmatics.

Konstantin Skoblik held a position of a senior lecturer in the Department of Criminal Procedure and Criminalistics at the Siberian Federal University (Krasnoyarsk, Russia) in 2015–2020. Prior to that he had worked as a trainee lawyer. Skoblik is a coauthor of *Grounds for Decision-Making in the Russian Criminal Process* (in Russian; “Urlitinform,” 2020) and “On the Public Model of the Russian Criminal Procedure” (*Journal of Siberian Federal University: Humanities & Social Sciences*, 2019), as well as several other publications on fact-finding in the criminal process in Russia. Since 2019 he has been conducting research in the field of sociology of law, and in his current research projects he analyzes the criminal process in Russia through the lens of Niklas Luhmann’s systems theory and carries out empirical studies on de-differentiation tendencies in the Russian criminal justice system.

Oksana Zaporozhets is Associate Professor at the Faculty of Urban and Regional Development and Head of the Laboratory for Urban Sociology, both at the National Research University Higher School of Economics (Moscow, Russia). Her current research projects focus on urban living in the city, including living in new urban areas, building neighbor relations, using new urban public spaces, creating urban imagery including graffiti and street art. She is a coeditor of two books on the city life (in Russian), *Micro-Urbanism: City in Details* (NLO, 2014) and *Urban Networks: People, Technologies, Governance* (NLO, 2021).
