

**Elizaveta Balatsyuk** is a PhD student in sociology at HSE University (Saint Petersburg, Russia). She studies gender regimes and norms in Saint Petersburg's Neo-Pentecostal Church. She is a participant of a research project carried out within the framework of the Basic Research Program by the HSE University's Centre for Youth Studies.

**Elena Bogdanova** is a research fellow at the Aleksanteri Institute, University of Helsinki. She has published nearly 70 articles, including in journals such as *Europe-Asia Studies*, *International Journal of the Legal Profession*, *Governance*, *Communist and Post-Communist Studies*, and *East European Politics*. Among her research interests are sociology of aging, research of justice and regulative systems, Soviet society and postsocialist transformations, and qualitative research methods. Bogdanova is a coeditor of *Communism and Consumerism: The Soviet Alternative to the Affluent Society* (2015) and the author of *Complaints to the Authorities in Russia: A Trap between Tradition and Legal Modernization* (2021).

Natalia Chernyshyova is a junior researcher in the Centre for Youth Studies at HSE University (Saint Petersburg, Russia) and a PhD student in sociology at HSE University. She studies youth migration and is also involved in research related to the sense of place and issues of inclusion of people with intellectual and mental disabilities. She is a recipient of a scholarship from the Potanin Foundation; in 2022 she was the runner-up in the Graduate of the Year competition organized by the All-Russian Center for Public Opinion Research and the winner of the research competition among HSE University students. Chernyshyova participates in a research project of the Centre for Youth Studies supported by a grant from the Russian Science Foundation.

**Dace Dzenovska** is an associate professor of anthropology of migration at the University of Oxford. Her research interests include the changing relationship between people, place, political authority, and capital in Eastern Europe and the former Soviet Union. She is the author of *School of Europeanness: Tolerance and Other Lessons in Political Liberalism in Latvia* (2018). She currently researches emptying towns and villages in Eastern Europe.

**Irina Lisovskaya** is a researcher in the Centre for Youth Studies of HSE University in Saint Petersburg, Russia. She is involved in multiple youth studies at the Centre (migration, generations, youth solidarity, youth policy, citizenship and civic engagement), and has also participated, as part of a research team from the Centre for Youth Studies, in an international project of sociological study of prisons. One of her latest

publications in the area of prison studies is an article coauthored with several members of the international project "In the Gulag's Shadow: Producing, Consuming and Perceiving Prisons in the Former Soviet Union" that appeared (in Russian) in the journal *Mir Rossii* in 2022.

**Jeremy Morris** is a professor in the department of global studies at the University of Aarhus. His research straddles disciplines, particularly critical political economy and anthropology, and is focused on understanding "actually lived experience" in Russia and other postsocialist states, particularly in relation to work, class, and the diverse economy. He has authored a number of books and articles, including *Everyday Postsocialism: Working-Class Life Strategies in the Russian Margins* (2016). He is the coeditor of *Varieties of Russian Activism* (2023), *The Informal Postsocialist Economy: Embedded Practices and Livelihoods* (2014), and *Informal Economies in Post-Socialist Spaces: Practices, Institutions and Networks* (2015).

Marianna Muravyeva is a professor of Russian law and administration at the University of Helsinki. Her research focuses on human rights of women, queer community, conservative jurisprudence, violence against women, and family violence. Muravyeva's latest publications include books Foundations of Russian Law (2023) and Parricide and Violence against Parents: A Cross-Cultural View across the Past and Present (2021), as well as edited volumes History of Gender-Based Violence in Eastern Europe (forthcoming in 2024) and Women's History in Russia: (Re)Establishing the Field (2014) and numerous articles and chapters.

**Judith Pallot** is a senior researcher at the Aleksanteri Institute, University of Helsinki, where she directs two grants on communist and postcommunist prison systems. She is an emeritus professor at the University of Oxford. She has been researching and teaching in Russian area studies for four decades. Pallot has published extensively in journals and is the author and coauthor of over ten books on rural society and Russian penal geography. Her most recent books are *Waiting at the Prison Gate: Women and Prisoners in Russia* (with Elena Katz; 2016) and *Gender, Geography and Punishment: Women's Experiences of Carceral Russia* (with Laura Piacentini; 2012). Her research is funded by the European Research Council's Horizon 2020 grant no. 788448.

**Fedor Veselov** is a graduate of the master's programs in sociology and anthropology at the European University at St. Petersburg (EUSP) and Central European University. He participated in the three-year research project "Culture of Happiness: The Role of Cultural Institutions in the Personal Well-Being of the Residents of Russia," based at EUSP and supported by the Potanin Foundation. Veselov is a contributor to the edited volume *The Politics of Memory in Contemporary Russia and Eastern European Countries: Actors, Institutions, Narratives* (in Russian; 2020). Currently Veselov is the curator of the Urban Anthropology and Urban Folklore seminar at EUSP and is affiliated with Indiana University. His research interests include critical urban theory, urban culture and economics, applied urban research, night studies, and memory studies.
