Françoise Daucé is professor at the School of Advanced Studies in the Social Sciences (EHESS, Paris, France) and director of the Centre for Russian, Caucasian and Central European Studies (CERCEC, EHESS-CNRS, Paris, France). Her research in political sociology focuses on the transformations of criticism and compromise in civil society and in the public sphere in contemporary Russia. She is the coordinator of the collective project ResiTIC (“Resistance on the Internet: Criticism and Circumvention of the Digital Borders in Russia”). She is the author of *Une paradoxale oppression: L’Etat et les associations en Russie* (CNRS Editions, 2013) and *La Russie postsoviétique* (La Découverte, 2008 and 2019). She is also the author of numerous academic articles on civil society and media in post-Soviet Russia.

Gilles Favarel-Garrigues is CNRS Research Professor at Sciences Po CERI (Paris, France). He holds a PhD in political science. He has published on issues of policing in contemporary Russia and on international mobilizations against transnational criminal threats. Favarel-Garrigues is the author of *Policing Economic Crime in Russia: From Soviet Planned Economy to Privatisation* (Hurst & Company, 2011) and has edited with Jean-Louis Briquet *Organized Crime and States: The Hidden Face of Politics* (Palgrave Macmillan, 2010). His current work focuses on vigilantism in general and in Russia in particular; his most recent English-language publication on this topic appeared in the journal *Global Crime* in 2019.

Rashid Gabdulhakov is a PhD candidate in the Department of Media and Communication at Erasmus University Rotterdam (Netherlands). As a member of an international team of scholars, he is researching the phenomenon of digital vigilantism and its manifestations in Russia and other former Soviet countries. Gabdulhakov teaches courses in academic skills, international and global communication, media systems in comparative perspective, and new media for integration.

Ekaterina Khodzhaeva received her PhD (candidate of sciences) degree in sociology from Kazan’ State University in 2003. She has been an Alexander von Humboldt Foundation German Chancellor’s fellow at the Research Centre for East European Studies at the University of Bremen (2009–2010) and a Fulbright fellow at the Davis Center for Russian and Eurasian Studies at Harvard University (2012–2013). Since 2013 she is a researcher at the Institute for the Rule of Law (European University at Saint Petersburg), where she focuses on studying Russian police, the legal profession, and the courts system. In addition to publishing frequently in Russian- and English-language academic venues, Khodzhaeva also disseminates results of her studies via Russian mass media.

Benjamin Loveluck is associate professor of sociology at i3-SES, Télécom Paris, and research associate at the Research Center for Administrative and Political Sciences (CERSA) at the University Paris 2 Panthéon–Assas. His research combines digital sociology and political theory and focuses on online political practices, the history of the internet, and the political economy of information. He is the author of *Réseaux, libertés et contrôle: Une généalogie politique d'internet* (Armand Colin, 2015). He is particularly interested in studying forms of self-organization and direct political action online, issues related to digital freedoms, as well as transformations of the public sphere. His recent work explores practices of online self-justice, or digital vigilantism, understood both as a form of social control and as political action.

Bella Ostromooukhova is associate professor of Russian language and culture at Sorbonne University (Center for Cultures and Societies of Eastern and Central Europe and the Balkans, Eur'Orbem) and research associate at the Centre for Russian, Caucasian and Central European Studies (CERCEC) at EHESS (Paris, France). She specializes in the sociology of culture; her current research focuses on internet regulation, censorship, and independent book publishing in post-Soviet Russia.

Ioulia Shukan received her PhD in political science from Sciences Po Paris in 2006. She is currently assistant professor in the Department of Slavic Studies at the University Paris Nanterre and research fellow in the Institute of Social Sciences of Politics. She is also member of the organizing committee of the annual Danyliw Seminar in Ukrainian Studies at the University of Ottawa (Canada) and of the International Social Science Summer School in Ukraine. Her current research interests are social mobilizations in the face of the war in Donbas (care of wounded combatants, vigilantism) and forms of citizenship in Ukraine. Shukan's recent publications include the book *Generation Maidan: Vivre la crise ukrainienne* (Editions de l'Aube, 2016) and an article on women's voluntary engagement in the care for wounded combatants in the special issue on the war in Donbas of the French journal *Revue d'études comparatives Est-Ouest*, which she also coedited.

Anna Zaytseva is associate professor of Russian studies at the University of Toulouse–Jean Jaurès (Laboratory LLA-CRÉATIS) and research associate at the Centre for Russian, Caucasian and Central European Studies (CERCEC) at EHESS (Paris, France). She specializes in sociology of arts, cultural practices, social movements, and urbanism. Her areas of interest include the study of urban youth cultures, the transformations of cultural industries and intellectual rights in the digital age, as well as the diversity and historical development of forms of political participation and protest at the intersection of art, activism, and alternative cultures. She is also involved in translation in social sciences and independent comics.
